Sri. Krishnan Kutty CPO 6581 has submitted an application before the Inspector General of Police, Tvpm Range regarding his SCPO promotion. He has represented that he had passed the General HC Test but not promoted as HC.. His request have been verified with the connected records and found that Sri. Krishnankutty CPO T 6581 has entered in service as Police Constable in Armed Reserve unit Thiruvananthapuram city during 1985. After long leave he has rejoined duty in 2001 and was transferred to local Police unit only on 29/01/2001.

The seniority of PCs in Local Police unit will be decided on the basis of joining duty in that unit. In the seniority list of Local PCs issued vide CO No235/2010TC dtd he was included as SI No1151. He has passed General HC Test conducted on 08/10/2006. His immediate juniors and seniors were included in the Provisional Select list of PCs eligible for promotion as HCs issued vide CO No 714/2015TC. But in this provisional select list the name of the applicant was not included due to omission and the applicant has not informed that fact before the finalisation of the list. The Finalised Select List was published vide CO No.787/2015TC dtd 07/07/2015.

In this select list his immediate senior PCT 9097 Sunderesan was included as SI No 79 and immediate junior PCT 9480 Lal babu was included as SI No 80.They were promoted as HCs vide CO No 788/2015TC dtd 9/7/15. As per the seniority list of Local PCs the turn for promotion of the applicant has arrived in 2015. Hence he is eligible for promotion as HCs along with his immediate junior and immediate senior.

Hence, Sri. Krishnan Kutty CPO T6581 is included in the Select List of CPOs issued vide order read as Illrd above as the SL No 79 (a) and provisionally promoted as Regular Sr.CPO with immediate effect and posted to Tvpm Rural, subject to the conditions detailed below.

This promotion will be subject to such conditions as may be prescribed by the govt. with

regard to the integration of AR cadre with General Executive (KCP). The promotee shall exercise options for fixation of their pay in the higher time scale under Rule 28-A, Part I KSRs, within one month from the date of order.

The DPC Thiruvananthapuram .Rural will admit him in the promoted post immediately and report compliance.
