Sri. All his qualified seniors were promoted before 2013. His name is to be included in the Provisional Select list of PCs eligible for promotion as HCs issued vide CO No 960/2014 TC.

In the circumstances Sri. Sudharsanan Kani K , PCT 7799 is included in the Select List of CPOs issued vide order read as Illrd above as the first person above SI No. 01 and provisionally promoted as Regular Sr.CPO with immediate effect and posted to Tvpm Rural.

The DPC Thiruvananthapuram .Rural will admit him in the promoted post immediately and report compliance.
